REGULAR MEETING

SEPTEMBER 3, 2024 At 3:30pm, Chairman Utke called the Foster County Commission meeting to order. Roll call included Commissioner Scott Beumer, Commissioner Becky Hagel, Commissioner David Utke Commissioner Pat Copenhaver and Commissioner Alan Scanson. Also present was Foster County State's Attorney Kara Brinster. Auditor/Treasurer Ellen Roundy Road Superintendent Nate Monson, Foster County Independent Reporter Nathan Price and Michael Rivinius with Wold Engineering.

The meeting began with ap proval of the minutes for the August 20th, 2024, regular meeting and August 20th, 2024, Special Meeting. Commissioner Scanson motioned to approve the minutes, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Commissioner Hagel motioned to approve the bills, seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner Copenhaver motioned to approve the agenda seconded by Commissioner Scanson. All voted aye and the motion

Old Business There was no update for the lots by Juanita Lake. Kip Kovar and Scott Mehring from Garrison Diversion and Vance Miller and Lauri Olson with Black and Veen joined the meeting regarding the Garrison Diversion Pipeline. Commissioner Utke stated that he has met with Garrison regarding a decision on whether to bore or cut the Dump Ground and Kensal roads for the pipeline and establishing an agreement. Kovar noted that in 2021 he had attended a meeting regarding the decision of the Bordulac road and assumed the BOCC would allow open cuts on all the roads, he prepared the bid of the dump ground road to be that of open cut without prior BOCC approval. The October 7th, 2021, motion read as follows: "Commissioner Scanson made a motion to allow the Garrison Diversion Contractor to cut open of the South Bordulac Road during the months of June and July for 5-7 days with paving, chip seal, and restoration along with detour in right of way, seconded by Commissioner Copenhaver. All voted ave and the motion passed." Commissioner Utke stated that allowing the open cut on the Bordulac Road was not a decision that encompassed all other roads with the pipeline. Commissioner Scanson stated that the State of ND will not allow an open cut on Highway 20, so why should the county allow open cuts on their roads. Michael Rivinius, Wold Engineering, noted that with an open cut, regardless of how well it is put back together, it's still going to ride like a patch. Commissioner Copenhaver asked if Garrison would be willing to make a payment to Foster County for allowing the open cut, while maintaining the road, but the money could be used contingent if the project runs out of money or goes away. Kovar noted that he would have to bring that to his superiors. Discussion included terms of an agreement and monetary compensation the BOCC would require. Rivinius also noted that Garrison did not get an easement for the Bordulac Road

Commissioner Scanson - aye motion passed. The BOCC will wait to hear back from Garrison on the agreement before making any

decision on the Kensal Highway. **New Business**

Nate Monson, Road Superintendent, provided an update for the road department. They have been working to patch spots on the Murphy highway and durapatching various spots on the Bordulac Road. They have started mowing

highway ditches for the fall and are prepping materials for the winter

Brent Hills, Bryant Johnson and Taylor Stewart joined the meeting representing CP rails to discuss road repairs. The BOCC wanted to contact CP and start the process of how county roads will be repaired from traffic due to the train derailment. Michael Rivinius, Wold Engineering, has provided a memo to all parties. The request for repair due to impact would be for patching project for breakups and distressed areas with an estimated cost of \$300,000 on the Murphy Highway. The nine miles of the Bordulac Highway have been adversely impacted due to the derailment with size, weight and number of trucks that have traveled the road to help with cleanup. Rivinius recommends a three-inch overlay estimated at \$3.9 million dollars Monson has kept great documents of upkeep and maintenance on the road due to the derailment. The BOCC and CP will continue to work together on an agreement for repair work necessary caused by the July 5th, 2024, train derailment.

Ellen Roundy, Auditor/Treasurer provided an update for the basement renovation project. Rough in work for electrical and HVAC is still in progress. They are wrapping up the men's restroom from phase one and will work to complete the gas line to the courthouse in the next month. Roundy also presented a local raffle permit for the Carrington Youth Football Club. Commissioner Copenhaver motioned to approve the permit, seconded by Commissioner Scanson, All voted aye and the motion passed.

Roundy presented options for the JD lawn mower. They have leased the current mower and could purchase it for \$2,868.24, a new three-year lease could start at \$2,230.10 with a buyout option estimated at \$4,000 or purchase a new mower and make four annual payments of \$2,663.98. Commissioner Scanson motioned to purchase out the current lease agreement for \$2,868.24, seconded by Commissioner Hagel. Roll call voted

Commissioner Beumer – aye Commissioner Hagel – aye Commissioner Utke – aye Commissioner Copenhaver

Commissioner Scanson – aye motion passed. Roundy also presented a new Quonset storage agreement at Juanita Lake to be approved with a rate of \$1.50/ square foot for winter storage Commissioner Scanson motioned to approve the agreement with the updated rate and to provide a 50% discount to Dennis Swanson for taking the time to arrange for individuals to store equipment, seconded by Commissioner Copenhaver. All voted aye and the motion passed. Commissioner Hagel would like the county to review the current policy manual and ensure employees understand ramifications if not followed. Commissioner Utke had received a call regarding installing a stop sign at the intersection of Grace City highway and McHenry/Barlow highway. He drove through the intersection from all four sides and recommended a stop sign replace the yield signs on the East and West side and update appropriate signs to warn of stop sign ahead. In the discussion, it was noted that there have been accidents, low visibility and two intersecting highways of higher speeds causing concerns and would justify changing the yield signs to stop signs. Commissioner Scanson motioned to approve the change of yield signs to stop signs and purchase appropriate signage for stop signs ahead, cross traffic doesn't stop, seconded by Commissioner Beumer. Discussion included that if State's Attorney Brinster found that the sign could not be changed to do so, but for safety reasons update the signs for now. All voted aye and the motion passed. Commissioner Hagel had attended a Central Prairie Human Service Zone meeting. Foster County will be receiving the 2024 indirect cost payment in October and Well's County Auditor is working on prior years' numbers.

With no further business, Chairman Utke adjourned the meeting at 5:27 pm.

PUBLIC HEARING SEPTEMBER 10. 2024

At 6:00 pm, Chairman Utke called the Foster County Commission Public Hearing to order. Roll call included Commissioner David Utke, Commissioner Alan Scanson, Commissioner Pat Copenhaver and Commissioner Becky Hagel (via phone). Also present was Foster County Auditor/Treasurer Ellen Roundy, Foster County Independent Report Amy Wobbema, Foster County Residents William and Stefanie Dillingham and Joann Unruh (via phone).

The purpose of the public hearing was to discuss the proposed 2025 Foster County Budget. William Dillingham spoke on the increase of taxes. Auditor/Treasurer Roundy stated that the residents of Foster County voted during the 2024 primary election to increase the current road mills from twelve to twenty-five, which was the main source of increase. Commissioner Utke noted that reports from the state are gathered along with from surrounding counties to ensure we are in line with compensation and benefits, which also increase from year to year. The county must operate and compete with inflation. Roundy noted that the general fund

levy from when she started through

2024 has decreased almost fifteen

percent and is still below the 2022

levied dollar amount. Entities that

are: County General, County Road Veterans Service, County Agent Ambulance, Capital Improvements Emergency, Public Health, Soil Conservation, Historical Society, CCEDC, Garrison Diversion, State Medical Center, Senior Citizens Water Board and Weed Board There are requirements in the North Dakota Century Code that require each county to maintain certain offices. Roundy also noted that many valuations went up. The state requires that values be within a certain percentage of the sales ratio. Due to houses selling for higher than valued, increases were required for many residential lots, commercial buildings also saw an increase. Commissioner Scanson noted that the BOCC is always welcome to suggestions and that BOCC meetings are open for the public to attend. If there is any service a resident would be willing to give up, they would consider it and break down what that cost savings would be. Commissioner Scanson stated that the BOCC does the best that they can do and understand it is public money being spent.

With no further business, Chairman Utke adjourned the meeting at 6:47 pm

New Business Ellen Roundy, Auditor/Treasurer presented the BOCC with the final 2025 budget for Foster Count. There were no requested changes from any commissioner. Commissioner Beumer motioned to approve the 2025 Foster County Budget as presented, seconded by Commissioner Hagel. Roll call vote included:

Commissioner Beumer - ave Commissioner Hagel – ave Commissioner Utke - ave Commissioner Copenhaver ave, motion passed.

A local raffle permit was turned in on behalf of Carrington Park Board. Commissioner Beumer motioned to approve the permit seconded by Commissioner Copenhaver. All voted ave and the motion passed. Roundy presented a contract for propane with Arrowwood Prairie Co-op. She spoke with Road Superintendent Nate Monson, and he recommended 650 gallons to start. Commissioner Beumer motioned to approve the contract with 650 gallons, seconded by Commissioner Hagel. All voted ave and the motion passed. Tax Director, Karen Evans, assisted with the remaining minutes.

Road Superintendent Nate Monson had previously provided an update to the BOCC on the road department. He indicated the need for a new pressure washer and received quotes from \$3,600 to \$4,500. Commissioner Beumer motioned to approve the Hotsie brand pressure washer from Gilbertsons for \$3,600, seconded by Commissioner Copenhaver. Roll call vote included:

Commissioner Hagel – ave Commissioner Utke – aye Commissioner Copenhaver aye, motion passed.

Public Notice

To date there has been 26.11 inches of rain in the Carrington area. The department has installed the stop signs with additional signage warning of stop sign on road North of Grace City on 11th street They will take docks out at Juanita Lake at the end of this month.

Chris Thomas, EAPC, called into the meeting for a building update. The second phase of the basement renovation is on track. The crews are currently working on taping, mudding and painting. Thomas presented a change order for the community room in the basement. The walls were not in as good condition as initially thought. General Roofing submitted a change order from the lumber yard to replace the wainscot in the community room for up to \$5,905. Commissioner Beumer motioned to approve the replacement of wainscoting in the community room, seconded by Commissioner Copenhaver. Roll call vote included:

Commissioner Beumer - aye Commissioner Hagel – aye Commissioner Utke – aye Commissioner Copenhaver aye, motion passed.

Commissioner Utke was in-

vited to attend the Griggs County Commissioner meeting to discuss Foster County's plans for the McHenry to Binford highway. Commissioner Utke noted that he gave no recommendation on any future plans Foster County will do on the road as the main concern areas are in Griggs County. He did provide them with a map that Mike Rivinius, Wold Engineering, provided for Foster County roads. It was noted that there will be a meeting with CP Rail on September 30th, at the Carrington Fire Hall. Foster County State's Attorney, Kara Brinster, wanted to provide additional clarification on the changing of the yield sign to a stop sign. To install a stop sign, there has to be an engineering study, or when a yield sign is already in the location, there must be reasons (low-visibility, accident prone area, high-traffic area, highspeed area, etc) to add a stop sign Many of the reasons applied when discussion at the September 3rd 2024, BOCC meeting so the stop sign could be installed.

With no further business Chairman Utke adjourned the meeting at 4:19 pm.

ANALYSES OF THE STATEWIDE MEASURES APPEARING ON THE **ELECTION BALLOT NOVEMBER 5, 2024**

The following analysis is for the measures appearing on the statewide General Election ballot on November 5, 2024. This publication is required by section 16.1-01-07 of the North Dakota Century Code to enable voters to become familiar with the effect of proposed measures. As required by section 16.1-01-17 of the North Dakota Century Code, a copy of the Legislative Council's report on the estimated fiscal impact is available from the North Dakota Office of the Secretary of State at vote.nd.gov. by phone at 701-328-4146, or by writing to the North Dakota Secretary of State, 600 E Boulevard Ave., Dept 108, Bismarck ND 58505-0500.

Analysis of Constitutional Measure No. 1 (Senate Concurrent **Resolution 4001, 2023** Session Laws, Ch. 597)

Constitutional Measure No. 1 was placed on the ballot by action of the 2023 North Dakota Legislative Assembly with the passage of

Senate Concurrent Resolution No. 4001 (2023 Session Laws, Chapter 597). If approved, this constitutional measure would amend and reenact sections 12 and 13 of article IX of the Constitution of North Dakota, relating to the replacement of outdated terminology describing public institutions of the state.

The proposed amended sec tions are summarized as follows: the "school for the deaf and dumb of North Dakota" is changed to the "school for the deaf and hard of hearing"; a "state hospital for the insane" is changed to a "state hospital for the care of individuals with mental illness"; an "institution for the feebleminded" is changed to a "facility for individuals with developmental disabilities"; and a "state hospital for the mentally ill" is changed to a "state hospital for the care of individuals with mental illness."

The estimated fiscal impact of this measure is none.

Analysis of Constitutional Measure No. 2 (Senate Concurrent **Resolution 4013, 2023** Session Laws, Ch. 598)

Constitutional Measure No. 2 was placed on the ballot by action of the 2023 North Dakota Legislative Assembly with the passage of Senate Concurrent Resolution No. 4013 (2023 Session Laws. Chapter 598). If approved, this constitutional measure would amend and reenact sections 2, 3, 4, and 9 of article III of the Constitution of North Dakota, relating to initiated constitutional amendments.

If approved, the proposed amendments would require both constitutional and non-constitutional initiated measures to be limited to one subject as determined by the Secretary of State, who may not approve the initiated petition if it comprises more than one subject; require that measure sponsors be qualified electors; require that only qualified electors may circulate a petition; require petition signers to provide a complete residential address; and increase the number of signatures required to place a constitutional initiated measure on the ballot from four percent to five percent of the North Dakota resident population. Additionally, the proposed amendments would require that constitutional initiated measures approved by the Secretary of State be voted upon by the voters at the next primary election and, if approved by a majority of the voters, voted upon at the general election immediately following the primary election; if the measure fails at either the primary or general election, the measure is deemed failed.

Analysis of Constitutional Measure No. 3 **Resolution 3033, 2023** Session Laws, Ch. 596)

Constitutional Measure No. 3 was placed on the ballot by action of the 2023 North Dakota Legislative Assembly with the passage of House Concurrent Resolution No. 3033 (2023 Session Laws, Chapter 596). If approved, this constitutional measure would amend and reenact section 26 of article X of the Constitution of North Dakota, relating to spending and transfers from the legacy fund.

The measure intends to decrease the amount of principal available for spending each biennium and clarify the distributions from the legacy fund. If approved, the proposed amendments would require transfers and earnings accruing prior to July 1, 2017 to be deemed as the principal of the legacy fund; reduce the amount of the principal of the legacy fund available to be expended during a biennium from fifteen percent to vestment board to invest the moneys in the legacy fund, not limited to the principal; and on July first of odd-numbered years, require the state treasurer to make a distribution of the legacy fund earnings into a legacy earnings fund.

Analysis of Initiated Constitutional Measure No. 4

Initiated Constitutional Measure No. 4 was placed on the ballot by petitions circulated by a sponsoring committee. If approved it would amend sections 1, 14, 15 and 16 and repeal sections 4, 5, 7 9 and 10 of Article X of the North Dakota Constitution.

If approved, it would prohibit political subdivisions from levying any tax on the assessed value of real or personal property, except for the payment of bonded indebtedness incurred through a certain date, and would require the state to provide replacement payments to political subdivisions of no less than the current real property tax levies. It would limit the debt of a political subdivision to an amount not to exceed two and one-half percent of the full and true value of the real property in the politica subdivision; however, by a vote, ar incorporated city could increase its indebtedness to four percent and a school district could increase its indebtedness to five percen It would allow an incorporated city to become indebted in an amoun not exceeding two percent of its ful and true value for water and sewer projects. It would require a politica subdivision incurring indebtedness to provide for annual revenues to pay the debt payments when due and would prohibit a politica subdivision from issuing genera obligation bonds secured with tax levied on the assessed value of

The estimated fiscal impact of this measure is \$3.15 billion increase in biennial expenditures to the state beginning in the 2025-2027 biennium.

Analysis of Initiated Statutory Measure No. 5

Initiated Statutory Measure No. 5 was placed on the ballot by petitions circulated by a sponsoring

If approved, it would create a new chapter of the North Dakota Century Code. It would allow for the production, processing, and sale of cannabis and the possession and use of various forms of cannabis by individuals who are 21 years of age and older; direct a state entity to regulate and register adult use cannabis production businesses dispensaries, and their agents provide protections for individuals who are 21 years of age or older who use cannabis; provide penal ties for violations of the chapter preserve certain employer rights regarding use of cannabis products by employees; supersede loca ordinances that otherwise would prohibit the purchase, sale, use delivery, or growing of cannabis by or to individuals 21 years of age or older: and provide that fees must be appropriated for administration

of this chapter. The estimated fiscal impact of this measure includes revenues of \$10,227,600, expenses of \$8,324,275, and an undetermined amount of additional costs associated with behavioral health and social impacts for the 2025-2027

ROADSIDE WEED AND GRASS MOWING NOTICE

Pursuant to NDCC 63-05-01. "It is the duty of landowners or operators with land adjoining regularly traveled county and township highways, as designated by the township board of supervisors in organized townships, the board of county commissioners in unorganized townships, and the board of county commissioners in the case of county highways, to cut all weeds and grasses along the regularly traveled highways adjoining their lands, including weeds and grasses growing within the public right of way bordering the highways and their lands. The cutting shall be completed not later than October 15th, as prescribed by the board of county commissioners.' The maximum stubble height shall be 4 inches and the width of cut shall be a

minimum of a 14-foot swath where possible. The roadsides on all county and township roads shall be mowed. Haying of the grasses within rights of way is permitted, but all stored hay shall be removed by November 1st of each year. "FAILURE TO CUT WEEDS AND GRASSES-EXPENSES LEVIED AS TAXES

AGAINST LAND." If the landowner or operator fails to cut the weeds and grasses along the designated highways or roads as provided in this chapter, the board of township supervisors or the board of county commissioners, as the case may be, may cause the weeds and grasses to be cut and actual expense of cutting shall be certified to the county auditor, all the excess shall be charged against the land of the landowners and shall become part of the taxes to be levied against the land for the ensuing year and shall be collected in the same manner as other real estate taxes are collected, and placed to the credit of the respective subdivisions entitled thereto NDCC 63-05-03.

Pursuant to authority vested in the above notice, the Board of County Commissioners and Township Supervisors of Foster County, North Dakota hereby designate October fifteenth as the deadline for completion of weed cutting.
